X International Scientific Conference Contemporary problems of economic development - Sustainable development

May 19, 2022 in hybrid form

Since 2014, the College of Economic and Social Sciences of the Warsaw University of Technology, Branch in Płock and KN SONDA have been organizing the International Scientific Conference "Contemporary Problems of Economic Development". This year is its jubilee, 10th edition.

The conference is addressed to research workers, ph.d. students and students of economic universities.

Thematic scope of the conference:

The main topic of the conference is the sustainable development of economies. "Sustainable development is a development in which the needs of the present generation can be met without detriment the ability of future generations to meet their needs." (Raport Brundtland 1987, World Commission on Environment and Development, "Our common future"). It aims to ensure economic development while protecting social and environmental balance. The role of sustainable development in modern economies is evidenced by the adoption by the European Union of a strategy for sustainable development in 2021 and the recognition of sustainable development as one of the long-term goals of the European Union. The aim of the Strategy is "to enable the implementation of a long-term vision of sustainable development, which combines mutually supporting economic growth, social cohesion and environmental protection".

Within this area, we propose thematic blocks based on five great transformational changes set out in the United Nations 2030 Agenda for Sustainable Development:

- 1) *People* reaching out to excluded groups, creating conditions and opportunities for the enjoyment of universal human rights and economic achievements for all people, guaranteeing equal access to economic resources, basic services, land, natural resources, technology and finance.
- 2) Planet creating solid foundations for sustainable development by integrating social, economic and environmental aspects of development, building a development model that will foster economic growth and greater social inclusion, and rationally use the resources of the natural environment, and thus achieve a better quality of life and solve the problem of poverty.
- 3) Prosperity transforming economies conducive to creating jobs and ensuring inclusive development, including shifting to sustainable consumption and production models, using new technologies and business potential, ensuring access to good education, health care, clean water, electricity, transport, telecommunications, facilitating business, investment, trade; intensifying the sustainable development of cities.
- 4) *Peace* building peace and effective, fair, open and responsible institutions guaranteeing the strengthening of the role of law, social inclusion and co-decision, strengthening the role and responsibility of institutions that should support the rule of law, property rights, freedom of speech and media, political freedom, access to justice, non-discrimination of anyone.
- 5) *Partnership* a new global partnership based on solidarity, cooperation, accountability and transparency of actions taken, this applies to partnerships between governments as well as local and regional administrations, academia, business and all interested parties and groups.

Submission of the article to the post-conference monograph – May 27, 2022.

Conference languages:

Conference presentations and scientific articles should be prepared in Polish, English or Russian.

Publications:

Articles, after a positive review and prepared in accordance with the editorial guidelines, will be published in the post-conference monograph (20 points of the Ministry of Science and Higher Education).

The publication should be prepared in accordance with the rules set out in the "Editorial guidelines of the post-conference publication". Publications not prepared in accordance with the guidelines will not be published.

Conference fee:

Participation in the conference is free. Cost of the post-conference publication (in printed version)– 50 PLN
